Explanation of Responses:

- Annual grant of restricted stock. One third of the restricted stock will vest annually beginning on February 27, 2013.
- Market Stock Units represent the right to receive shares of common stock, subject to the achievement of certain performance conditions. Market Stock Units vest 3 years after issuance and are converted into a number of shares of common stock depending on total shareholder return over the vesting period.
- Represents the maximum number of shares that may be issued with respect to the Market Stock Units issued. The actual amount of shares issued, if any, will depend on total shareholder return at the end of the vesting period.
- The Market Stock Units vest 3 years from the date of issue and convert into a certain number of shares of common stock as discussed in Footnote 2.
- Represents the maximum total number of shares that may be issued with respect to the aggregate number of Market Stock Units issued.
